Old business (AMENDED):


- Discussed the Solar Panel Roof Project, not moving forward at this time

Discussion Items

When I return in September, I would like for us to craft an engaging 3-year strategic plan. What's our compelling "why" as a community?

Information Items

Chasity is getting updated quotes on the fire panel/fire alarm system. As of this writing (6/21/25), I don't have more to share about this.

The Unity convention went well (though I physically felt lousy for most of it). There is general consensus for the acquisition of UWM by UWH; however, crucial details remain unsettled.

I'll take two months of my three month sabbatical starting on Saturday, June 28th and return to the office on Tuesday, September 2nd. I will be giving staff explicit instructions this week and am especially grateful for Sherrie and Bowman's support in this time. All Sunday speakers are booked.
