Context and Accomplishments

- 1. Accomplishments: We are thankful
- 2. New reality of our post-pandemic world
- 3. Pathways forward: *In spirit, we are not limited*



New Reality: Financial Trends

Key items to bring to the attention of our community

- Pandemic has disrupted normal member gain/loss membership down 15-20%
- Pinnacle Academy 2020 departure reduced rental income \$7K/month
- New virtual participants tend to give much less

Result: Reduced love offerings creating monthly operating losses of \$10K+ that continue to consume cash reserves at an unsustainable rate

However, we have the potential to revive membership and love offerings with concerted effort, but we are assuming not in the near term (2023)



Actions Taken through this Year

- Membership analysis and contact to re-engage
- Renewed emphasis on short-term rentals
- Expense reduction: staff; service contracts; discretionary costs
- Close cash management
- Update of Mildred Park Endowment Guidelines, including annual withdraw policy
- 66th Anniversary Campaign

We need to do more.



Overview of Alternative Pathways

The board is evaluating a range of large and small actions to close the revenue gap. The actions have **different timelines** with **varying degrees of certainty and impact**, and they are **not mutually exclusive**.

Near Term

Stay the course (continue building membership)

Intermediate Term

New revenue sources (rental emphasis)

Expense reduction (Staff focus)

Longer Term

Partial real estate sale (Mildred Park Center)

Total real estate sale Church merge



Pathways Forward: Spiritual Discernment

- Board of Trustees want to share potential paths which align with our Vision and Mission and take us through 2023 and beyond
- #1 Ongoing initiative: Reinvigorate Unity of Fairfax Membership
- Paths may be combined and some stand-alone. All paths provide varying degrees of long-term revenue and impact.

Pathway #6: Total remake/real estate sale

Pros

- Opens up vast new possibilities
- Out of the box thinking
- Might leverage proceeds from sale of entire property to serve mission and vision

Cons

- Highly disruptive
- Requires much energy and imagination to create the new "reality"
- Loss of our five sacred acres and history, which hold deep appeal

- **Considerations**
 - Likely beyond 2023
 - Destroys continuity of our church



Pathway #5: Church merge

Pros

 Potential to share facility costs

Cons

- Difficulty in finding a suitable match
- Indeterminate impact of needs, costs and staff
- Potential dilution of Unity energy, vision and mission

Considerations

 Timing uncertain given finding suitable match



Pathway #4: Significant budget tightening

Pros

 Most direct way to respond to income/expense imbalance

Cons

- Inflexibility of most expenses requires reshaping staff
- Disruption of church functions
- Commensurate burden on member volunteers
- Unanticipated consequences disrupt vision and mission

Considerations

- Have already been doing
- Requires immediate planning
- Does this align with vision and mission



Pathway #3: Stay the course

Pros

Minimal change

Cons

- Further reduction of cash reserves and emergency use of Mildred Park Endowment
- Requires major fundraising efforts
- No time for correction if income/expense imbalance persists

Considerations

Not sustainable



Pathway #2: Partial real estate sale

Pros

- Pays off mortgage loan
- Reduces monthly budget by \$2-3k
- Remaining proceeds could be put in Mildred Park Endowment for long-term use
- Reduces rental property management time/costs

Cons

- Breaks up five sacred acres
- Requires short-term use of reserve cash
- Reduces rental income potential
- Potential unforeseeable issues with new neighbor

Considerations

- Doable, realistic in 2023
- Requires \$75k and six months preparation, permits, etc.
- Acknowledgement we have not used MPC for at least 10 years
- Irreversible choice



Pathway #1: New revenue sources

Pros

The "right"
 arrangement could
 create a reasonable
 revenue stream

Cons

- Heavily dependent on unknown opportunities
- Lackluster history of partial rentals and new fundraising efforts
- Refocus on moneygeneration not directly related to church vision and mission

Considerations

- Need one or two arrangements immediately
- May run counter to our pre-pandemic membership intent
